No charge for calls you do not answer; you will be charged each time you call out regardless if there is an answer on the other end. Taxes and \$1.00 Administrative Billing Fee will be charged on all plans. Text messaging, downloads and other features will be an extra charge. A \$15 activation fee will be charged for all new accounts. Directory assistance calls are billed at \$1.75 per call in addition to airtime charges. An approved digital Verizon phone is required for digital service. **Up to five lines can share. Shared phones don't share features, they only share minutes. Custom Calling Features (included free with each rate plan) include: basic voice mail (airtime is charged to check messages), caller ID, call waiting, and 3-Way calling (will double minutes used). *\$15.00 Data-If you go over the 150MB, you will automatically be charged an additional \$15.00 for another 150MB. It won't be sold per MB.**
